NOTIFICATION

NO.SO (Admn) 15-63/2014/ 2219-2401 With the prior approval of the competent authority, the following "District Education Authority" is constituted to perform the delegated powers as notified by the Government of Baluchistan with immediate effect and until further orders:-

Composition

1. District Education Officer, as Chairman of the Authority;
2. The Deputy commissioner or his Representative of Deputy Commissioner, as member;
3. The District Accounts Officer/ Treasury Officer or his representative as member;
4. The District Officer Education (Female) as member;
5. The District Officer Education (Male) as member;
6. The Deputy District Officers (Female and male) with regard to issues to their respective jurisdiction;
7. The Head Master/ Mistress with regard to issues related to the school teachers/staff of their respective schools;
8. Female/Male Learning Coordinators with respect to issues of teachers posted in their respective jurisdiction.

Functions

The "District Education Authority" shall perform such functions, as may be notified by the Provincial Government, through the official Gazette notifications.

Guidelines and Method for performance of business by District Education Authority.

1. The District Education Authority shall perform its functions collectively in formal meetings to be held on weekly basis ;
2. No meeting of DEA shall be considered valid without attendance and signatures of members from S.No 1 to 3.
3. All the members including the Chairman, except S.No 2&3 shall attend the meetings in person and representation shall not be allowed in any case.
4. All the members including chairman shall have equal right in the proceedings and decisions of District Education Authority.
5. The Authority shall draw its minutes and every member shall affix her or his signature with date and time on every page of minutes of a meeting;
6. The minutes of the meeting of DEA shall be issued by DEO with his own signatures;

7. Every member of the Authority shall have the right to disagree and record a dissent note;
8. The decision of Authority on any item shall be invalid if 50% of total number of members express their disagreement to the decision;
9. In case of 50 percent disagreement of the members, matter shall be referred to Divisional Director (Schools) for review, concurrence or advice as the case may be.
10. The decision of Divisional Director Education (Schools) shall be final on any matter referred by the "District Education Authority".


